Sir,

We are directed to bring to your kind notice that your letter to us on the subject issue just on the eve of our CEC meeting to be held at Jabalpur was sufficient, to mislead the CHQs as well as various branches. At the last moment many branches had to decide to reduce their number of Delegates for CEC Meeting while, on the others hand, some branches decided not to attend the meeting. At many of our branches, the Delegates had already booked their Rly. Tickets (to and from) and were forward with the grant of special C.L. for the purpose of attending the meeting at Jabalpur. Many such Delegates had to cancel their tickets and journey for CEC meeting. Besides, the host branch i.e., Jabalpur branch had to suffer a lot and to face many unwanted problems at the last moment as a result of the contents of your said letter to the CHQ under intimations to Local Authorities. Stipulation for grant/admissibility of Special C.L. might have been intimated after the already decided CEC Meeting at Jabalpur i.e., without disturbing this important meeting. Truly speaking, SGO's such letter on the eve of this CEC meeting mislead us (both CHQs and Branches) to the large extent. The entire things were discussed threadbare in the just- concluded CEC meeting.

For the host Branch the number of all the Executives/delegates.

3. The Associations has reasons to hope that the SGO Administration Will be kind to appropriate our difficulties from practical points of view and approve our request/suggestions as mentioned in para 2 above.
