Kindly refer contents of my above mentioned letter to the DST which speaks of itself in the copy of which you were requested to kindly expedite SGO's reply/resubmission of C.R. Proposals to DST keeping obviously into view our considered modifications submitted to S.G. & Ministry from time to time in general and in between 2014 to 2017 in particular.

2. Kindly also refer my letter No. J-MSA/Svy/19/2017 dated 14/15.09.2017 to the-then S.G. with copy endorsed to the Hon'ble J.S. (Adm.) & Director SMP Division at D.S.T. amongst others.

The letters in question on the subject 'Implementation of long-overdue Cadre Restructuring right at DST-level itself' being quite detailed, exhaustive & self-explanatory ones in all respects I need not dwell any further upon the inner things as contained therein. I have reasons to hope that the contents of these two very important/significant letters were seriously gone through by SG and concerned responsible officials in the SGO Administration and the Ministry i.e. DST have been duly approached to complete their process aimed at finally implementing the 14-years-long C.R. Issue actively considering the staff side's points-cum-modifications on one hand and DST's letters/reminders to SG dated 12.08.2016, 06.10.2016 & 22.11.2016 on the other.

Sir, as a very senior and all-along important/responsible official in the Surveys it is not unknown to your kindself that as a result of quite unnecessary dilly-dallying in implementation of the C.R. not only a pretty large number of employees/staffmembers retired from service in between 2004 to 2017 (long 14 years) but also many a staffmember expired during such long period. Needless to say that all of them and their families too suffered and were sadly deprived of their legitimacies from out of their C.R. Benefits for no fault of their own but exclusively on account of administrative delay on part of the Secretariate. Anyway, kindly do the needful now at

the earliest, if not already done keeping in view that almost in every month of a year some employees are retiring in some of the survey stations and are getting deprived of their promotions/benefits from out of the C.R.
