Sub.: Implementation of unnecessarily long-pending CADRE RESTRUCTURING from back date (due date) right at DST- level itself on warfooting emergency basis – Request for immediate necessary action from your end, if not already done in the meantime.

Sir,

Respectfully I like to bring home to you that due to non-implementation of the much-needed as well as long-overdue CADRE RESTRUCTURING during the pretty long period of 14 (fourteen) years the staffmembers on one hand while the entire Organization of MSA, SOI on the other have, obviously, been suffering from a sizeable degree of mental unrest and dejection and further continuance of such dilly-dallying on this exclusive/instant burning issue in the so-called name of processing and processing sine die is bound to have unfortunate bearing upon the efficiency and output of the overburdening ministerial cadres of this oldest CG Department.

2 Sir, the detailed contents of all the three letters under reference being quite exhaustive and self-explanatory ones in all respects. I hardly need to dwell any further upon the compendium or, say, inner things as contained therein albeit I will say simply but remind your kindself seriously that during the last 14 years (i.e. from 19th December, 2003 upto this April, 2018) many senior employees retired either on superannuation or voluntarily while many a staffmember breathed their last being sadly deprived of their promotional benefit-cum-career advancement from out of the 2nd Cadre Review which is now the much-spoken-of CADRE RESTRUCTURING. And, needless to say, some very senior employees at this survey station or the other are retiring almost in every month of the years being unfortunate victims on account of deprivations of their legitimacies as a result of pitiable delay in implementation of the long-cherished C.R. Should it not be construed to be a brazen assault either on the fitness of things or on the question of democratic fabrics as proclaimed by the Union Governments from time to time? I will, however, earnestly expect that the matter in question i.e. the Cadre Restructuring will be implemented in no time under your Secretaryship right at DST- level itself.

3 Relevantly I like to remind You, JS(Adm.)&Director, DST(SMP) that the Surveyor General of India has ultimately resubmitted the Final & Modified C.R. Proposals to DS&T in the 4th week or so of March, 2018 for your valued consideration and, secondly, a Team of Representatives of MSA including the Secretary General have met DS&T Officials and discussed the matter i.e. the C.R. in details during their visit to SGO on 10th & 11th instant.

4 At length, for your kind ready reference, I take the opportunity to honourably remind you of the important letter dt. 20.03.2018 of Shri M. Krishnan, Secretary General of the Confederation of CGEs&Ws, New Delhi & Member of the Standing Committee of National Council (JCM) addressed to Dr. Harsh Vardhan, Hon'ble MIC, Min. of Sc&Tech, GoI with copy to the Minister of State for SC.&Tech&ES, you & me the excerpts of which read as under:

Sub: Implementation of long overdue Cadre Restructuring in respect of Ministerial Staff, Survey of India – Reg.

It is reported that the Cadre Restructuring of Ministerial Staff of Survey of India is pending for the last Thirteen (13) years, with the Govt. of India, Ministry of Department of Science & Technology. The Final Cadre Restructuring proposal was sent from Surveyor General of India to Department of Science and Technology vide No. W-762/709-Cadre Restructure dated 18th March 2016 for DS & T's perusal and further necessary action.

Sir, the employees are much frustrated due to the inordinate delay in finalizing and implementing the Cadre Restructuring. We are at a loss to understand why this much delay is taking place at the level of Department of Science and Technology in processing and finalizing such an important issue relating to the employees, whereas in many other departments the Cadre-Restructuring is implemented in a time-bound manner. Department of Personnel & Training has also issued clear instructions to carry out Cadre Restructuring in a time-bound manner.

In view of the above, the intervention of the Hon'ble Minister is requested, so that ~~the~~ Cadre Restructuring of Ministerial staff of Survey of India will be expedited and implemented at the earliest.

A line in reply from your end will be highly appreciated."
