Comrade,

At the outset let us once again express our sincere thanks for your attending our 14th A.I.C. at Jaipur on 8th Nov., 2017 as also for your valuable address thereat. Your detailed speech delivered on the 7th CPC issue had given a lot of educative values to one and all of our Delegates / Leaders of CHQs & Branches attending the AIC from length & breadth of the Country. Comrade, it will be recalled that at the end of your speech in the AIC We had some discussions with you in connection with our longawaited CADRE RESTRUCTURING (since unnecessarily pending for more than 13 years with the G.O.I., Ministry & Deptt. Of Science & Technology) and on hearing us you had been pleased to assure of your as well as the Confederation's looking into the matter aimed at doing the needful at your earliest convenience. In this regard we told you that a 3 – Member Team of ours including JCM Member & Secretary General of MSA had met JS (Adm.) & Director, SMP at their office in New Delhi wherein we expressed due concern and manifested the degree of grievances of the staff side for their inordinate dilly-dallying on the question of Implementation of Cadre Restructuring. In their turn the official side stated that they were waiting for the Surveyor General of India's reply / clarification to their as many as 3 queries / reminders sent by them to SG, Dehra Dun during 2016. On our efforts we got a copy each of those 3 letters / reminders from the Ministry i.e. D.S. & T and submitted appropriate letter to SG, D'Dun urging him to send replies to the Ministry's letters / reminders immediately. By this time the Administration of the new Surveyor General are expected to have taken necessary action in that they will have sent replies / queries to D.S&T's letters/reminders. Relevantly it is worth-mentioning for your information that the Final Cadre Restructuring Proposals were sent from S.G. to DS&T vide No.W-762/709-Cadre Restructure dt. 18th March, 2016 for DS&T's perusal and further necessary action.


