Sub: Intimation of the changed date for the proposed Meeting with the Staff side of M.S.A well in advance

Ref: My letter No. J-MS/Svy/08/2018-19 dated 09/10-07-2018 to S.G. with copy to the COBs of MSA, SoI sent by E-mail (copy enclosed for kind ready reference).

Sir,

Your kind attention is hereby drawn to the contents of my important letter quoted under reference wherein you were requested to kindly decide the changed date for your official meeting with the staff side of MSA at the earliest and intimate the same to us well in advance but it is unfortunate that your good office (SGO) has not yet been able to get the things done, albeit the points from our side as agenda-items were already submitted for you by our secretary General vide No. CHO-13/MSA (2018) dated 13th June 2018 for discussion in the meeting since earlier scheduled to be held on 11th July, 2018 at 11 am. A copy of the said letter of mine is enclosed for your kind ready reference and earliest necessary action.

2. I re-iterate that instead of being cancelled the proposed meeting should/could have been deferred or postponed till some further date. So it is wondered as to how the meeting was stated to be cancelled when your official meeting was already held with the class III Service Association the recorded minutes of which were duly circulated to all concerned. I fail to make out any cognizable reason as to why the question of your firstever full-fledged official meeting with the Ministerials had lost its importance & dignity.



As the present Surveyor General you are soon going to complete your first year in early September 2018 and, as such, this is the high time for completing the cherished meeting with us without any further delay. It is not unknown to the SGO Administration that our CEC meeting at Jabalpur (M.P.) is going to be held on 25th & 26th September, 2018.

So, keeping in view all such things, I am to solicit the favour of your immediately deciding the date for meeting with us and intimating the same well in advance in order to enable us to avoid unnecessary reservation problems in trains. Any date in between 6th to 7th September, 2018 or 11th to 12th September, 2018 will facilitate us. The immediate needful may, therefore, kindly be done.
