Sub: Immediate Implementation of the quite unnecessarily long-pending CADRE RESTRUCTURING at DST-level itself – Urge for

Ref: My letter for your kindself vide No. J-MSA/Svy./07/2018-19 dt. 09/10.07.2018 with copy to SG, Addl. SGs & Directors amongst others (copy enclosed).

Sir,

I have the honour to invite your kind attention to the letter quoted above which is detailed and self-explanatory one in all respects. A copy of the said letter is enclosed for your kind information, ready reference and earliest necessary action under intimation to us.

2. In the said letter of mine I had genuinely requested you kindly to complete this oldest important chapter for Implementation of the 15-year-long Cadre Restructuring actively considering the MSA (staff side)'s views/amendments/modifications on warfooting emergency basis. But, it is unfortunate that the same kinds of dilly-dallying exercises are being still adopted at the Secretariat meaning obviously that the spirits of letters/correspondences etc. on the subject issue from the Secretary General of the confederation of CG Employees & Workers, Cabinet Minister i.e., MIC, Ministry of Science & Technology (GoI) and the JCM Member (DC) have hardly been given any due/proper cognizance of despite lapse of time, This is Unique(!).

3. It is, perhaps, not in the minds of responsible DST Officials that during the last 15 years (starting from December, 2003 upto this period) some hundreds of staffmembers retired from services while many a person passed away in harness thereby being sadly deprived of their legitimacies in the shape of promotions/cadre upliftments from out of C.R. Implementation. Endless lethargy coupled with avoidable procrastination on part of as many as 5 Hon'ble Secretaries and innumerable responsible officials at the DST from time to time in completing processes stands as the root cause of all such things.

4. Now, however, I like to state that the present Surveyor General of India had been pleased to submit before the DST the consolidated & Final Restructuring Proposals on 13<sup>th</sup> March, 2018 for further necessary action. But, after seeking some clarifications and/or raising some queries, the C.R. Proposals are learnt to have been returned to SGO for resubmission which have since been resubmitted from SGO to DST sometime in May, 2018 i.e. as good as clear 3 months back. The strength of ministerial cadres viz. senior E&AO, DD(O.L), Asstt. Director (O.L), E&AO, Office Suptdt., Assistant, UDC, LDC, Senior H.T. & Junior H.T. as finally proposed / recommended in March, 2018 by S.G. is, on the whole, satisfactory & acceptable to me and the staff side of MSA and, as such, it is urged that this strength of ministerial cadres gets duly accepted and implemented without least delay at DST-level itself. And, as a prelude to the overall exercise of C.R. Implementation, the proposed / recommended strength of atleast E&AO (40) & OS (130) (falling short of the requirements) may kindly be sanctioned & implemented in no time in the overall interest of the functional needs.

5. Immediate needful may, therefore, kindly be done in this regard. Kindly take a little trouble to acknowledge receipt of this important letter.
