Sir,


It is really a pity that in spite of our pretty long wait with all patience & endurance as also after sending quite a large number of correspondences including important resolutions of Kolkata AIC in 2012, Bhubeneshwar CEC in 2013, Bangalore AIC in 2014 & Ranchi CEC in 2016 the much-needed and long-cherished CADRE RESTRUCTURING is yet to be implemented with the obvious result that the CHOs & Branches of MSA, SOI on one hand while the members on the other are totally disappointed and the Organization as a whole is suffering from simmering discontentment. In this regard it is stated that behind such an abnormal delay or time-killing no comprehensible reasons have been shown or intimated to us (recognized organization) so far from DST's end. I do refer Judgement of the Hon'ble Apex Court on "Rajkishore Jhar-vs-Union of India & Others" where the Hon'ble Supreme Court held that reason is the heart beat of every conclusion and without the same it is lifeless. Hence due to non-informing the reason for not yet implementing the 14-year-old C.R. the Hon'ble Supreme Court's mandatory ruling has been knowingly ignored/violated.

2. Anyway, this is to inform you (Hon'ble Secretary), Jt. Secy. (DST), Director SMP Division and concerned others that on account of urgent/important organizational work myself, Shri DCR Karki (Secy. Genl.) & 2 others are reaching New Delhi on 5<sup>th</sup> Sept, 2017 morning from Jaipur and our team will stay there upto 6<sup>th</sup> Sept, 2017 afternoon for Association activities. In this opportunity we shall call on your kindself at DST on any day in between 5<sup>th</sup> and / or 6<sup>th</sup> Sept, 2017 at 11-30AM/ 12PM, personally hand over copies of some letters etc. (still unreplied/unresponded to from your end) and discuss thoroughly over the vitally burning issue of C.R. aimed at making an end to our long-cum-unilateral wait for its implementation.

3. In view of the above kindly arrange to remain at your good offices (DST) on the above mentioned days. I shall contact over telephone and / or fax from Rajasthan GDC & Delhi GDC and inform the exact date & time of our arrival at DST for your kind convenience.
